## IMPORTANT NOTES

Travel Time Charges – Should travel time to (respectively from) the starting point of the assignment exceed 60 minutes, the client will be charged for the actual travel time using the public transport system starting from (respectively ending at) Central Station. In case the client provides for transportation to/from the assignment outside the inner city, the client will be charged for the time of departure from (respectively to) Central Station.

**Reimbursement of Travel Expenses** – All travel expenses – except those for public transport within Zone A – will be charged to the client. For travel to/from the airports the client will be charged for transportation by the Airport Coach, unless other means of transport have been agreed upon.

**Reporting for duty** – Should the client request the guide to report for duty more than 15 minutes before the start of the assignment, the client will be charged for the time exceeding 15 minutes.

VAT - The Swedish VAT of 25 % will be added to the fees/charges listed above in accordance with the law.

## **Cancellation rules**

#### **Guest cancellation**

- If possible, cancellations shall be made directly to the guide, preferably by phone. If it is impossible to reach the guide by phone, other means, such as e-mail or answering machine, may be used.
- When a cancellation is made 48-24 hours prior to the tour, a base fee is charged
- When a cancellation is made less than 24 hours prior to the tour, a fee for the whole tour is charged
- For "NO SHOW" a fee for the whole tour is charged
